

# **PRIVACY POLICY**

The Privacy Policy of personal data (hereinafter "Privacy Policy") applies to all information that GeoManna and / or its affiliates may receive about the User while using their site: geomanna.com (hereinafter "Website").

Use of the Website Services means the User's unconditional consent to this Policy and the terms of processing of his personal information specified therein, in case of disagreement with these conditions, the User must refrain from using the Services.

## **1. GENERAL PROVISIONS**

1.1. Use of the Website by the User means acceptance of this Privacy Policy and the terms of processing of the User's personal data.

1.2. This Privacy Policy applies only to the data of the Website and doesn't control or be responsible for third party sites to which the User may click on the links available on the Website.

1.3. The Administration of the Website doesn't verify the authenticity of the personal data provided by the User to the Website.

## **2. PRIVACY POLICY OBJECT**

2.1. This Privacy Policy establishes the obligations of the Administration of the Website to not disclose and provide a regime for protecting the confidentiality of personal data that the User provides upon the request of the Administration of the Website during registering on the site.

## **3. PURPOSES OF COLLECTING PERSONAL USER INFORMATION**

3.1. The Administration of the Website may use the User's personal data for the following purposes:

3.1.1. Identification of a User registered on the Website.

3.1.2. Granting the User access to the personalized resources of the Website.

3.1.3. Identifying of the User's location for security and fraud prevention.

3.1.4. Confirmation of the authenticity and completeness of personal data provided by the User.

3.1.5. Messages to the Website's User with additional information.

## **4. METHODS AND TERMS OF PROCESSING PERSONAL INFORMATION**

4.1. The processing of the User's personal data is carried out without any time limit, in any legal way, including information systems of personal data using automation tools or without using such means.

4.2. The User agrees that the Administration of the Website has the right to shares personal data with third parties.

4.3. The User's personal data can be transferred to the authorized bodies of the government only on the grounds and in the order established by the legislation.

4.4. The Administration of the Website takes necessary organizational and technical measures to protect the User's personal information from unauthorized or accidental access, destruction, modification, blocking, copying, distribution, as well as from other illegal actions of third parties.

## **5. PROCESSING OF PERSONAL INFORMATION USING COOKIES**

5.1. The User is aware that the equipment and software used to visit sites on the Internet may have the function of prohibiting operations with cookies (for any sites or for certain sites), as well as removing previously received cookies.

5.2. The Administration of Websites has the right to establish that the provision of a certain Service is possible only provided that the reception and receipt of cookies are authorized by the User.

## **6. OBLIGATIONS OF THE PARTIES**

6.1. The user is obliged to:

6.1.1. Provide information about the personal data which is necessary to use the Website;

6.1.2. Update and supplement the information provided on personal data in case of changing such information.

6.2. The Administration of the Website is obliged: To take necessary and sufficient organizational and technical measures to protect the User's personal information from unauthorized or accidental access, destruction, modification, blocking, copying, distribution, as well as from other illegal actions of third parties.

## **7. ADDITIONAL CONDITIONS**

7.1. The Administration of the Website has the right to amend this Privacy Policy without the consent of the User.

7.2. The new Privacy Policy comes into force from the moment it is posted on the Website, unless otherwise provided for in the new edition of the Privacy Policy.
